1 Introduction

An important part of the relationship we have with our clients is the information you share with us. Protecting your privacy is important to us and we want you to know how we treat your nonpublic personal information. As we are an independent Registered Investment Advisor (RIA) and not part of a larger financial institution, we do not share your information to promote banking or financial arrangements. We passionately believe in keeping your information secure and useful only to help you with your Lloyd Tevis' financial plans, investment advice, and monitoring and notifying you of changes.

Pursuant to Title V of the Gramm-Leach-Bliley Act and United States Securities and Exchange Commission ("SEC") Regulation S-P (17 CFR 248.1 – 248.30), this document explains the Privacy Policy of Lloyd Tevis Investments, LLC. Lloyd Tevis Investments, LLC is a limited liability company with its office in Lafayette, California. Lloyd Tevis Investments, LLC is an investment adviser registered with the Securities and Exchange Commission in Washington DC. Lloyd Tevis Investments, LLC's principal business is to act as an investment adviser in accordance with all laws, rules and regulations applicable to investment advisers and the business conducted by investment advisers. As an investment adviser, Lloyd Tevis Investments, LLC's principal business is to provide investment advisory and investment management services to clients.

The policy of Lloyd Tevis Investments, LLC is to protect the confidentiality, integrity and security of any nonpublic personal information of its clients and prospective clients, and to prevent unauthorized access to, or the use or disclosure of such information. In its capacity as an investment adviser, investment manager, and in conducting its advisory business, Lloyd Tevis Investments, LLC receives and/or comes into contact with certain nonpublic personal information concerning its current and/or former customers. Lloyd Tevis Investments, LLC receives and/or comes into contact with the nonpublic personal information only for purposes of conducting its business as described above. Any and all such nonpublic personal information is hereinafter referred to as "nonpublic personal information." For convenience, "you" or "your" refers to any and all client(s) described above and "we," "our" and "us" refers to Lloyd Tevis Investments, LLC throughout this document.

2 Our Commitment to You

We do not sell or use your information without your consent. We are committed to safeguarding the use of your nonpublic personal information. We protect the security and confidentiality of the nonpublic personal information we have collected, and make efforts to ensure that such information is used only for proper business purposes in connection with the management or servicing of your account. Our relationship with you is our most important asset. We understand that you have entrusted us with your nonpublic personal information, and we do everything we can to maintain that trust.

We do not sell your nonpublic personal information to anyone. Nor do we provide such information to others except for discrete and proper business purposes, in connection with the servicing and management of your account as discussed below.

Details of our approach to privacy and how your nonpublic personal information is collected and used are set forth in this Privacy Policy.

3 Definitions

- Affiliates Companies related by common ownership or control. They can be financial and non-financial companies. We do not share your nonpublic personal information with any affiliates.
- Non-Affiliates Companies not related by common ownership or control. They can be financial and non-financial companies. We do not share your nonpublic personal information with non-affiliates except as describe in this notice.
- **Joint Marketing** A formal agreement between non-affiliated financial companies that together market financial products or services to you. We do not engage in joint marketing.

4 Nonpublic Personal Information Collected

In conducting business as described above, Lloyd Tevis Investments, LLC collects (or may collect), for example, the following types of nonpublic personal information:

- Information you specifically disclose to us in your life inventory, such as:
 - 1. Your life goals and plans, especially with regard to employment, changes in family structure, change of legal residence and disposition of your estate.
 - 2. Demographic information concerning the members of your household and other familial relationships.
 - 3. Your personal wealth, including investments, real estate, life insurance, pension and social security benefits, earning power and any other assets or streams of income which you may possess.
 - 4. Your debts, whether secured, unsecured or moral obligation.
 - 5. Any policies which control the financial management of your property.
 - 6. Details of any income taxes you may be subject to.
 - 7. Confidential personally identifying information such as name, address, and account numbers at financial institutions.
 - 8. Information regarding your security holdings and transactions.

This information is obtained (or may be obtained) in writing, in person, by telephone, electronically or by any other means.

- Additional information which may be disclosed to us by third parties, either at your direction or as part of servicing relationships you approved or through operation of law. Examples of such information could include credit scores, income and tax reports and reports including personal identifying information.
- Finally, Lloyd Tevis Investments may collect additional information through its ordinary business practices, such as providing telephone support, soliciting client feedback and receiving responses to marketing surveys or promotions.

5 Information About Your Web Browser Session

Web browser session data is nonpersonal information transmitted automatically to us from your computer or mobile device when you interact with our online service using your computer browser or a Lloyd Tevis Investments, LLC mobile app. Web browser session data may include your computer's IP address, the type of internet browser and operating system you are using, mobile device platform, type of Java Virtual Machine, Internet connection speed and identification of any hardware or software that has previously caused technical problems with the Lloyd Tevis Investments, LLC service. Web browser session data also included the pages and information you access on our service. Collection and analysis of web browser session data permits your computer or mobile device to connect with and navigate our service more effectively. Web browser session data will not be used to identify your personally.

6 Information Stored On Cookies

Cookies are small strings of digitized text that our online service transmits to your computer, and that will send certain information to our website when you are connected to the service. Cookies are used to record user names and password so that you are not requested to re-enter that information each time you use the service. We also use cookies to understand which parts of our service are most popular, where visitors and users are going on our service, and how much time they spend there. Cookies are read only by the server that places them, and are unable to execute any code or virus.

If you do not wish to have cookies storied on your computer, you may instruct your browser to block them, erase them, or warn you before a cookie are stored. Please refer to your browser instructions or help screen to learn more about these functions. However, blocking or erasing cookies may prevent you from using some functionality of our website.

7 Anonymized and Aggregate Information

Besides the personal information, web browser session data and information storied on cookies that we collect directly from you and your computer or mobile device, Lloyd Tevis Investments, LLC uses personal information to generate categories of non-personal information:

Anonymized data which relates to individuals but replaces names and other personally identifiable information with coded entries that do not disclose individual identities.

Aggregate data which relates to collective characteristics of our clients, such as the percentage of users that live in specific ZIP codes that cannot be used to identify individual users.

Lloyd Tevis Investments, LLC may share anonymized data with our research team.

Lloyd Tevis Investments, LLC uses aggregated information for such purposes as to operate and enhance our services, target promotions to users, and statistically analyze the usage of our website to improve the content, layout, and service of the website and enhance our marketing and promotional efforts. We may share aggregated information with third parties, such as our partners or general public, for education, research, marketing, and promotional purposes.

8 How We Protect Your Information

Lloyd Tevis Investments, LLC has implemented physical, administrative, and technical safeguards to protect client's personal information from unauthorized access, disclosure and use. Our physical measures include restrictions of access to areas and facilities in which personal information is stored or where that information may be accessible, and secure disposal of records and storage media. Our administrative measures include restrictive granting and denial of systems access privileges, secure administration of passwords and other access credentials, periodic security risk and compliance assessments, and data security training for all employees with access to personal information. Our technical measures include encryption of all personal information sent over public networks or stored on portable media and implementations

and updatings of firewalls. Lloyd Tevis Investments cannot be responsible for the security practices of third parties.

9 Nonpublic Personal Information Disclosed to Affiliates and Non-affiliated Third Parties

We disclose to affiliates and non-affiliated third party's nonpublic personal information only in connection with us providing investment management services or in respect of conducting our investment advisory business. Such disclosures include, among other things, information related to transactions, settlement, billing, payment, processing, clearing, transferring, reconciling, collection and tax reporting. Such disclosures may be provided to affiliates and non-affiliated third parties:

- 1. as necessary for rendering service
- 2. as you direct or consent
- 3. by operation of law

10 Former Customers

We treat former customers with the same privacy policies that we use for active customers. We will disclose nonpublic personal information about former clients of our investment advisory and investment management business only as permitted and/or required by law or legal process, or with the former client's consent.

11 When You Can Limit Sharing

Federal law gives you the right to limit the sharing of your nonpublic personal information, when: (1) sharing is for affiliates' everyday business purposes, (2) sharing with affiliates is done to use your information to market to you, and (3) sharing with non-affiliates is done to use your information to market to you. We do not share your information in any of these ways. State laws and individual companies may give you additional rights to limit sharing.

12 Confidentiality and Security of Nonpublic Personal Information

We are committed to implementing and maintaining commercially reasonable and appropriate measures to maintain your nonpublic personal information in a secure and confidential fashion. Our information security procedures include, but are not limited to, the following features:

- 1. Access controls on customer information systems, including controls to authenticate and permit access only to authorized individuals, and controls to prevent our employees from providing nonpublic personal information to unauthorized individuals who may seek to obtain this information through fraudulent means
- 2. Physical access restrictions at locations such as buildings, computer facilities, and record storage facilities, in order to restrict access of nonpublic personal information to unauthorized individuals.
- 3. Encryption, where appropriate, of electronic customer nonpublic personal information.
- 4. Segregation of duties for our employees with responsibilities necessitating access to nonpublic personal information
- 5. Monitoring systems and procedures to detect actual and attempted attacks or intrusions into information systems containing nonpublic personal information
- 6. Response programs that specify actions to be taken when we suspect or detect that unauthorized individuals may have gained access to nonpublic personal information
- 7. A disaster recovery plan to protect against loss or damage to nonpublic personal information due to potential hazards, such as fire and water damage or technological interruption or failure.
- 8. We regularly review, revise and update our information security procedures to account for changes in technology.

13 Maintenance of Records

Nonpublic personal information about you will be maintained during the time you are a client, and for the required time thereafter that such records are required to be maintained by federal and state securities laws. After this required period of record retention, all such information will be destroyed.

14 Notice to Clients

We will send you notice of our Privacy Policy annually for as long as you maintain an ongoing relationship with us. Periodically we may revise our Privacy Policy, and will provide you with a revised policy if the changes materially alter the previous Privacy Policy. We will not, however, revise our Privacy Policy to permit the sharing of nonpublic personal information other than as described in this notice unless we first notify you and provide you with an opportunity to prevent the information sharing.

15 Opting Out

Section 502(a) of the Gramm-Leach-Bliley Act generally prohibits a financial institution, directly or through its affiliates, from sharing nonpublic personal information with a non-affiliated third party unless the institution (i) provides the consumer with a notice of the institution's privacy policies and practices, (ii) provides the consumer with a clear and conspicuous notice that the consumer's nonpublic personal information may be disclosed to non-affiliated third parties, (iii) gives the consumer an opportunity to opt out of that disclosure, and (iv) informs the consumer how to opt out.

Clients cannot opt out of allowing Lloyd Tevis Investments, LLC to share their nonpublic personal information with non-affiliated third parties which are necessary to service their accounts such as Custodians, Third Party Administrators or certain software vendors. We do not share client information with any third parties that do not need the information in order to provide some type of service for your account.

17 POLICY

Lloyd Tevis Investments, LLC ("Lloyd Tevis Investments, LLC") adopted this policy with recognition that protecting the privacy and security of the nonpublic personal information we obtain about our clients is an important responsibility. We also know that you expect us to service you in an accurate and efficient manner. To do so, we must collect and maintain certain nonpublic personal information about you. We want you to know what information we collect and how we use and safeguard that information.

17.1 WHAT INFORMATION WE COLLECT

We collect certain nonpublic personal information about you (such as your name, address, social security number, etc.) that you provide on applications or other forms as well as communications (electronic, telephone, written or in person) with you or your authorized representatives (such as your attorney, accountant, etc.). We also collect information about your brokerage accounts and transactions (such as purchases, sales, account balances, inquiries, etc.)

17.2 WHAT INFORMATION WE DISCLOSE

Lloyd Tevis Investments, LLC does not disclose the nonpublic personal information we collect about our clients to anyone except: (1) in furtherance of our business relationship with clients, and then only to those persons necessary to effect the transactions and provide the services that clients authorize (such as broker-dealers, custodians, independent managers etc.); (2) to persons assessing our compliance with industry standards (e.g., professional licensing authorities, etc.); (3) our attorneys, accountants, and auditors; or (4) as otherwise provided by law.

We are permitted by law to disclose the nonpublic personal information about you to governmental agencies and other third parties in certain circumstances (such as third parties that perform administrative services on our behalf). These third parties are prohibited to use or share the information for any other purpose. If you decide to either terminate our services or become an inactive client, we will continue to adhere to our Privacy Policy, as may be amended from time to time.

17.3 SECURITY OF YOUR INFORMATION

We restrict access to your nonpublic personal information to those employees who need to know that information to service your account. We maintain physical, electronic and procedural safeguards that comply with applicable federal or state standards to protect your nonpublic personal information.

17.4 CHANGES TO OUR PRIVACY POLICY OR RELATIONSHIP WITH YOU

Our policy about obtaining and disclosing information may change from time to time. We will provide you notice of any material change to this policy before we implement the change.

17.5 OPTING OUT

Clients cannot opt out of allowing Lloyd Tevis Investments, LLC to share their nonpublic personal information with non-affiliated third parties which are necessary to service their accounts.
